The American President is an enthralling account of American presidential actions from the assassination of William McKinley in 1901 to Bill Clinton's last night in office in January 2001. William Leuchtenburg, one of the great presidential historians of the century, portrays each of the presidents in a chronicle sparkling with anecdote and wit. Leuchtenburg offers a nuanced assessment of their conduct in office, preoccupations, and temperament. His book presents

countless moments of high drama: FDR hurling defiance at the "economic royalists" who exploited the poor; ratcheting tension for JFK as Soviet vessels approach an American naval blockade; a grievously wounded Reagan joking with nurses while fighting for his life. This book charts the enormous growth of presidential power from its lowly state in the late nineteenth century to the imperial presidency of the twentieth. That striking change was manifested both at home in periods of progressive reform and abroad, notably in two world wars, Vietnam, and the war on terror. Leuchtenburg sheds light on presidents battling with contradictory forces. Caught between maintaining their reputation and executing their goals, many practiced deceptions that shape their image today. But he also reveals how the country's leaders pulled off magnificent achievements worthy of the nation's pride.

When the famous South African fish scientist Professor JLB Smith published *Old Fourlegs - The Story of the Coelacanth* in 1956 he created an international sensation. After all, this 400-million-year-old fish, known only from fossil remains, was thought to have become extinct around 66 million years ago! JLB Smith's dramatic account of the discovery of the first and second coelacanths in 1938 and 1952 turned him into a cult figure and put South African science on the world map. His book was eventually published in six English editions and translated into nine foreign languages. Mike Bruton's *The Annotated Old Fourlegs* includes a facsimile reprint of the original book, to which he has added notes and images in the margins that provide an interesting and revealing commentary on Smith's text, as well as new introductory and explanatory chapters that bring the coelacanth story up to date.

Parties, Polarization and Democracy in the United States

As evidenced in the 2008 elections and the transition to a new era of Democratic governance, one of the most important developments in American politics in recent years has been the resurgence of political parties. Democrats and Republicans represent different world views and

policies, citizens recognise these differences, and many of them use party labels to make sense of the political world. *Parties, Polarisation and Democracy in the United States* describes and analyses the place of political parties in American politics today - both among elites and citizens at large. Many scholars and pundits denounce political polarisation; they view it as a symptom of a broken political system that provides unappealing choices for voters and that is frequently mired in deadlock. Baumer and Gold make a different argument - that party polarisation offers the kind of choice and accountability to voters that was not always present in earlier periods of American political history.

Has politics reached breaking point? Rather than defending liberalism or abandoning it, how can a socially just and ecological alternative be built? Peadar Kirby investigates the causes of our current multifaceted global crisis by drawing on the work of Karl Polanyi. This book explores Polanyi's theory that social disruptions result from the attempt to run society according to the rules of the market. Drawing on these ideas, it outlines pathways towards an alternative future that overcome weaknesses in Marxism. Linking the ecological, political and socio-economic crises, Kirby identifies that an alternative socio-ecological model is emerging, consistent with the insights of Polanyi. *Karl Polanyi and the Contemporary Political Crisis* is an urgent intervention into key debates on the future of politics, on the low-carbon transition, on automation and on the emerging world order.

Some of the nation's leading experts look at various aspects of election administration, including issues of ballot format, changes in registration procedures, the growth in the availability of absentee ballot rules and other forms of 'convenience voting', and changes in the technology used to record our votes. Gore* decision has been used by courts that monitor the election process and at the consequences of changes in practice for levels of invalid ballots, magnitude of racial disparities in voting, voter turnout, and access to the ballot by those living outside the United States. The editors, in their introduction, also consider the normative question of exactly what we want a voting system to do. An epilogue by two leading election law specialists looks at how election administration and election contest issues played out in the 2012 presidential election.
