



Dear employees of Bloomsburg University, California University of Pennsylvania, Cheyney University, Clarion University, East Stroudsburg University, Edinboro University, Indiana University of Pennsylvania, Mansfield University, Lock Haven University, Kutztown University, Shippensburg University, Slippery Rock University, and West Chester University:

As you are aware, a Right-to-Know Law request has been filed by Pennsylvanians For Union Reform seeking your names and home addresses. Your respective Universities and the Pennsylvania State System of Higher Education ("PASSHE") have denied access to your home addresses in response to the request.

The request concerning your home addresses has been appealed to the Office of Open Records ("OOR"). As your home address has been requested, you may seek to participate before the OOR. If you participate, you may submit evidence and argument concerning why your home address should not be subject to public access. If you do not seek to participate before the OOR, your home address may be released and found to be publically accessible. Accordingly, **YOU MAY WISH TO CONTACT LEGAL COUNSEL CONCERNING THIS MATTER.**

In order to seek leave to participate before the OOR, please complete the attached form and return it to the below e-mail address corresponding to the University with whom you are employed **prior to July 10, 2015**. If you are accepted as a direct interest participant, you will be permitted to provide additional information demonstrating why your home address should not be subject to public access by **August 10, 2015**.
